

DIAGNOSUS CONTEST RULES

Effective Date: Jun 14, 2021

The following Contest Terms apply to all contests related to the DiagnosUs platform (each a “Contest,” collectively “Contests”), and should be read alongside the particular Contest Rules for the particular contest in which you wish to participate. No purchase or payment is necessary to enter or win any Contest. A purchase or payment does not increase your chances of winning any Contest. Violation of the Contest Terms or Contest Rules may result in disqualification, in addition to any other remedies available to us under the DiagnosUs [Terms of Service](#).

1. Sponsor.

The Contests are sponsored by Centaur Diagnostics, Inc. (“Sponsor”), 883 Boylston St, Ste 2, Boston, MA 02116. The Contests are not sponsored, endorsed, administered by, or associated with any other company or service provider, including but not limited to Apple Inc., Facebook Inc., Twitter, Inc., LinkedIn Corp. or their respective parent entities, subsidiaries or affiliates.

2. Eligibility.

The Contests are intended to be open only to individuals who are legal residents of the United States, Puerto Rico, and the District of Columbia who are at least eighteen (18) years of age at the time of entry. While users outside of the United States, Puerto Rico or the District of Columbia may voluntarily participate in Contests, Sponsor does not guarantee that prizes may be available to such users, and may choose to withhold prizes from such users in its sole discretion. Employees of Sponsor, its parent entities, affiliates, subsidiaries, advertising and promoting agencies, suppliers, and any other entity involved in the development or administration of the Contests, as well as immediate family members or household members of such employees, are not eligible to participate in the Contest. VOID WHERE PROHIBITED BY LAW.

3. Entry Period.

The start and end dates and times with respect to each Contest (the “Entry Period”) will be posted in the Contest Rules. The official timekeeping clock for each Contest shall be Sponsor’s clock.

4. How to Enter.

No purchase or payment is necessary to participate in any Contest. You may enter each Contest by completing each of the following steps:

- 1) Download or open the DiagnosUs Application downloaded through the App Store on your mobile device, and either:
 - a. if you already have a DiagnosUs account, log into your existing DiagnosUs account, or
 - b. if you do not already have a DiagnosUs account, register an account through Facebook, LinkedIn, or valid email address.

2) Select the Contest that you would like to enter and follow the instructions on the Contest page during the Entry Period with respect to such Contest to submit one (1) entry.

Each person may enter each Contest only as many times as is indicated in that contest's Contest Rules. In the event that a person attempts to submit a greater number of entries than allowed in the Contest Rules, all of that person's entries will be deemed void. Any attempted form of entry into any Contest other than as described in the Contest Terms and Contest Rules, or any incomplete entry, is void.

Sponsor reserves the right, in its sole discretion, to void any and all entries of an entrant, or prohibit the participation of any person, who Sponsor determines, in its sole discretion, is responsible or otherwise involved in any actual or attempted (i) fraud, tampering, or impairment or disruption of the administration, security, fairness, or proper play of any Contest, or (ii) violation of the Contest Terms or Contest Rules. Sponsor is not responsible for entries that are submitted but not received or accepted for any reason, including but not limited to lost, late, incomplete, damaged, or otherwise impossible to process entries, whether caused by technical failures in the entry process (e.g., website crash), unauthorized or fraudulent interference, or any other reason. Any such entries are deemed void.

5. Prizes.

Subject to these Contest Terms and relevant Contest Rules, the winner(s) of each Contest (the "Winner") will receive a prize determined in Sponsor's sole discretion and as set forth in the Contest Rules (the "Prize"). Rules concerning multiple winners are set forth in the Contest Rules.

In no event shall Sponsor be obligated to award any prizes other than the Prize specified in the Contest Terms and relevant Contest Rules. No prize substitution shall be permitted except in Sponsor's sole discretion. The Prize is not assignable and nontransferable. Any and all prize-related expenses, including, without limitation, any and all federal, state, and local taxes, shall be the sole responsibility of the Winner. Sponsor does not guarantee that the Prize can be made available to the Winner. If the Prize is unable to be fulfilled to the Winner due to any applicable law, rule, or regulation, or if the Winner cannot claim the Prize for any reason, then Sponsor reserves the right to not award the Prize at all.

6. Winner Selection and Notification.

Subject to these Contest Terms, the Winner(s) will be the person(s) who successfully meet the criteria as set forth in the relevant Contest Rules. Sponsor will select potential Winners within 30 days following the end of the Entry Period with respect to each Contest, from among all entries received during the Entry Period with respect to such Contest and submitted in accordance with the Contest Terms and relevant Contest Rules. Each potential Winner will be timely notified by email within 30 days after the following selection of the potential Winner(s). In the event a potential Winner cannot be contacted, is deemed ineligible, fails to claim the prize within 30 days from the time the award notification was sent, fails to timely return a completed and executed declaration and release as required, or is otherwise disqualified from the Contest, as determined in the sole discretion of the Sponsor, the Prize may be forfeited and an alternate potential Winner will be selected.

A potential winner may be disqualified from the Contest if they fail to comply with each provision of the Contest Terms and relevant Contest Rules, as determined in the sole discretion of the Sponsor. Sponsor is not responsible for failed, returned or misdirected notifications based on inaccurate information provided

by the potential Winner(s) in connection with an entry, entries and responses to winner notifications which are lost, late, incomplete, damaged, or otherwise not received by the intended recipient in whole or in part, or for computer or technical errors of any kind which may limit an entrant's ability to participate in the Contest, or other similar error in the Winner selection process. Sponsor reserves the right to cancel all or part of the Contest and to declare a potential Winner ineligible in such a situation. Sponsor has the exclusive power to interpret the Contest Terms and Contest Rules, and Sponsor's decisions regarding any and all matters related to the Contests are final and binding.

Sponsor reserves the right, in its sole discretion, to cancel or suspend any Contest at any time before or after the expiration of the Contest's Entry Period should technical causes or errors made by Sponsor corrupt the administration, security, or proper operation of the Contest. Sponsor also reserves the right to cancel any Contest for any reason or for no reason whatsoever prior to that Contest's Entry Period.

2) Indemnity. In addition to the indemnification obligations set forth in the DiagnosUs Terms of Service, by entering the Contest, you agree to release, defend, indemnify, and hold harmless Sponsor and their respective shareholders, officers, directors, managers, agents, parent entities, subsidiaries, representatives, attorneys, assigns, agents and licensees (collectively, "Released and Indemnified Parties") from and against any and all claims, liabilities, damages, losses, and expenses including, without limitation, reasonable legal and accounting fees, arising out of or in any way connected with any third-party claims brought or asserted by any party against any of the Released and Indemnified Parties arising out of or in connection, directly or indirectly, with the entrant's entry in any Contest, participation in such Contest, the Prize(s) with respect to the Contest, and/or use or misuse of such Prize(s).
